Example: Correct and Complete Child Care Attendance Forms received by January 2, 2012 will be processed, and reimbursement will be deposited by January 20, 2012. Child Care Attendance Forms received between January 3, and January 9, 2012 will be processed, and reimbursement will be deposited by January 27, 2012.

The cut-off date **will not be extended** when SFCS-observed holidays fall on Mondays.

Note: Regardless of when CCAF's are received by SFCS, they are not payable until the month after the services are provided. SFCS operates on a fiscal year calendar which runs from July 1 through June 30. CCAF's for each fiscal year must be received by SFCS no later than August 20th of the following fiscal year in order for SFCS to issue payment. If these forms are not received by SFCS in time, payment for the services provided will then be the responsibility of the parent.
